POLICY OBJECTIVE

The purpose of this policy is to provide guidelines for the consistent and flexible approach to the installation and maintenance of gates and grids for the control of stock on or adjacent to Shire roads, whilst managing road safety for the travelling public and reduce risk to Council.

EFFECTIVE DATE AND POLICY REVIEW

The policy shall be reviewed every four years or earlier if required by legislation, Council resolution or recommendation of the General Manager. If the policy is not reviewed within this timeframe, it remains active until such time as it is reviewed or revoked by Council.

This policy comes into effect on 1 May 2017.

POLICY

1 GENERAL

Where fencing of the road is not feasible or practical, a stock grid or gate in accordance with this policy and Part 9 Division 2 of the Roads Act 1993 may be installed. However, erection of new grids and gates across public roads for control of stock, security, etc is not permitted unless it is the replacement or upgrade of an existing grid or gate or the grid or gate forms part of an animal proof fence as determined by Land and Property Information NSW.

2 GRIDS AND GATES

A stock grid or gate in accordance Council Standards and the requirements of the Roads Act 1993 may be installed where fencing of the road is not feasible or practical. All stock grids shall be installed with a 6m wide double gate by-pass. Where this is not feasible or practical, the minimum width of the stock grid shall be 3.6m. All grids and gates are to be constructed in compliance with the Roads Act 1993 and Road Regulation 2008.

The application process for the construction of grids or gates on public roads under the Road Regulation 2008 requires that Council must consult with the public relating to the proposed installation using the local newspaper. Any costs associated with public consultation will be borne by the applicant. Council must have due regard to any written submissions on the proposal.

2.1 Ownership

As stock grids and gates are farm management devices, any and all costs (including maintenance) associated with them being on a road shall be borne by the landowner.

2.2 Maintenance

Landowner shall be responsible for the maintenance of stock grids or gates and their approaches. More specifically, landholders are required to clean out the grid pits, repair or replace broken pits, repair or replace broken and corroded rails, repair or replace wings and maintain the road to the acceptable standard to Council for 20m either side of the grid or gate. Grids and gates may be inspected as part of the Shire road inspection regime to ensure that they are being properly maintained so as to minimise Councils liability. Where maintenance is required, it shall be brought to the landholders notice in writing, requiring that the maintenance be undertaken within 60 days of receipt of the notice. If the maintenance is not undertaken within the 60 days, then Council may undertake the maintenance or removal and where possible recover costs from the landowner, including travel time.

As required by the Roads Regulation 2008, gates must be white and the posts on either side fitted with reflectors facing both directions along the road. This includes the side structures for grids.

2.3 Funding

All costs associated with the purchasing, installation, upgrading and maintenance of a grid or gate shall be borne by the landowner(s).
